Study Sources D and E below and answer the question which follows.

Source D

The JPs deal with robbers, thieves, and vagabonds, conspiracies, riots, and violence, and all other misdemeanours in the country. Each JP has authority upon complaint made to him of any theft, robbery, manslaughter, murder, violence, riots, unlawful games, or any such disturbance of the peace, to commit the person to the prison. A few lines signed in his hand is enough for that purpose. These JPs meet four times in the year to deal with all the misdemeanours.

[Sir Thomas Smith, one of Queen Elizabeth I's Privy Councillors, writing in his book *De Republica Anglorum [The Government of England]* 1556]

Source E

He must make himself perfectly acquainted with all the parts of the streets, courts, thoroughfares, outhouses of the area constituting his beat. He is also expected to possess such a knowledge of the inhabitants of each house as will enable him to recognise them. He is further expected to patrol every part of his beat once every ten, or at least fifteen minutes.

[James Grant, a journalist, describing the role of a police constable in his book *Sketches in London* 1838]
