[Recruitment in the eighteenth century]

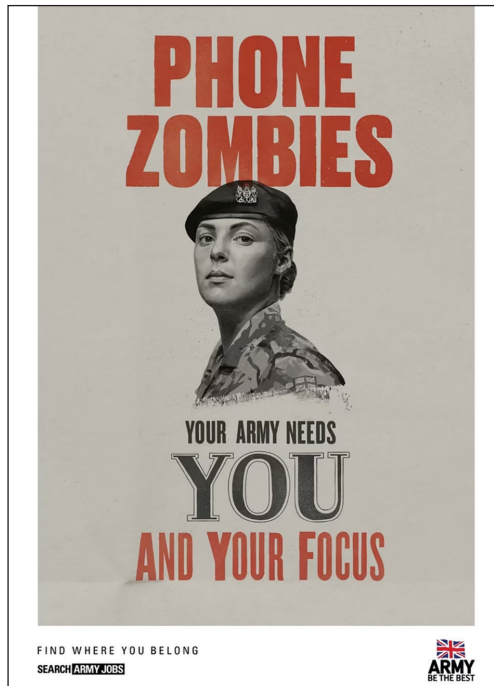

QUESTION 2

Study Sources D and E below and answer the question which follows.

Source D

Just before we began our attack, Prince Rupert passed from one wing of our army to the other, giving orders to the cavalry, to ride as close as possible, to receive the enemy shot, without firing our pistols, till we broke in amongst the enemy. After meeting some resistance we were masters of their cannons.

[Sir Richard Bulstrode, a Royalist officer, writing about the Battle of Edgehill in a letter to his family October 1642]

Source E

The Army will take steps to deceive the enemy as to the real front of attack, to wear him out, and reduce his fighting efficiency both before and during the battle. This will be achieved by preparing our trenches and gun emplacements; cutting the enemy's barbed wire to make attacking easier; gas attacks to cause enemy casualties; artillery barrages to destroy enemy communications.

[General Douglas Haig, commander of the British Army, writing in his battle orders issued just before the Battle of the Somme May 1916]
